

## Key Investor Information

This document provides you with key investor information about this fund. It is not marketing material. #### Objectives and Investment Policy

The objective of the Fund is to provide capital growth whilst being managed so as to remain, over a market cycle, within a defined volatility range.

The Fund will primarily gain exposure indirectly via eligible collective investment schemes and other collective investment vehicles (for example, investment companies, exchange traded funds) to a range of eligible assets such as transferable securities (shares (including investment trusts), debentures, government and public securities, warrants or certificates representing certain securities), money market instruments, deposits, cash, property and commodities) to provide diversification. The Fund may also invest directly in such eligible assets (excluding property and commodities).

Derivatives will be used only for the purpose of Efficient Portfolio Management.

The Fund will seek to remain within a defined volatility range over a market cycle – it will aim to be positioned as a 5 on a risk scale of 1- 10 (with 1 being the lowest risk and 10 being the highest risk). For this purpose, a market cycle is expected to be a minimum 5-year period. Risk profile ratings will be calculated by an independent third party.

Remaining within the volatility range will take precedence over the other objectives of the Fund, although the Investment Manager may in exceptional circumstances operate outside this range where it considers it is in the best interest of shareholders.

Typically, the Fund is likely to have greater exposure to underlying equities and commodities, and less exposure to underlying cash, fixed interest and property assets, than other funds in the range.

Investors can redeem shares on demand, at the daily valuation point of 12 noon (UK time) when this is a normal business day in the UK.

The Fund is not managed to generate an income. For accumulation shares, any income received is reflected in the price of the shares.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money in the short-term (within 5 years). The Fund should be viewed as a medium to long-term investment only.

#### Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.

The fund has been classed as 4 because its volatility has been measured as average.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.

## Charges

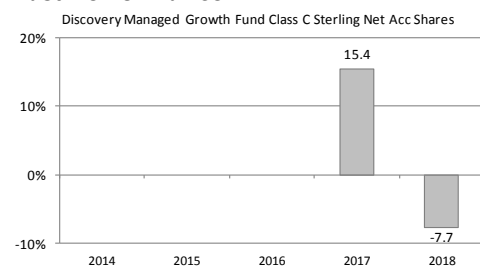
You may also be charged a dilution levy on entry to or exit from the fund.
