Further to our letter of 23 March 2021, we write to provide an update and to inform you that:

- (i) The final capital distribution has been set with ex-date 31/12/2021 and pay date 28/02/2022; and
- (ii) This constitutes the final realisation of value in the Fund so all shareholdings can now be written off.

Claim

We noted in prior letters dated 25th July 2019 and 23rd March 2021 a claim against the Fund. In connection with the proceedings of the claim previously outlined, we also filed a claim to the US internal revenue service in respect of withholding tax which could be due to the Fund. The success of this claim resulted a further sum of \$1,179,316.50 USD being returned to the Fund.

Liquidation of investments

The underlying investments of the Fund have also been sold down, resulting in an additional £90,000.00 (estimated awaiting finalisation of a corporate action on one holding) to return to shareholders, bringing the final estimated capital distribution to £2.1 million from the Fund. This payment is expected to be made on or before 28 February 2022.
