#### Objectives and Investment Policy

##### Objective

The Fund aims to provide a positive capital return over a 12 month period regardless of market conditions with a low level of volatility.

##### Investment Policy

The Fund invests in collective investment schemes which provide exposure to a variety of asset classes. Some of the collective investment schemes have total return objectives with the aim of providing a positive return in all market conditions. Corporate debt securities and structured products are also held.

Essential features of the Fund:

The Fund has the discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.

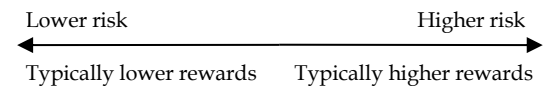
The Fund has no specific target market, asset class or geographic sector.

This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The on-going charges figure is based on expenses and the net asset value as at 15 November 2017. This figure may vary from year to year. All of the on-going charges are taken from the income of the Fund. They exclude portfolio transaction costs, except in the case of an entry/exit charge paid by the fund when buying or selling units in another collective investment undertaking. They include charges for the operation and management of the fund which consists of a fixed fee of £12,000 per annum plus an investment management fee of 0.60% per annum.

The Fund's annual report for each financial year will include detail on the exact charges made.

You may also be charged a dilution levy on entry to or exit from the Fund.
