Objective and Investment Policy

The Fund aims to provide capital growth over the long term by investing in a mix of UK and overseas assets, which may include:

- shares
- bonds issued by companies, governments and other organisations
- other investment funds, and
- cash, deposits and money market instruments.

The Fund has no specific target market or focus on any geographic region.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

The Fund has the discretion to invest in a range of investments as described above.

You can buy and sell shares in the Fund every Tuesday and on the last working day of each month.

If you hold accumulation shares, any income from the Fund will be reinvested to grow the value of your investment.

If you hold income shares, any income from the Fund may be paid out to you.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The fund has been classed as 4 because its volatility has been measured as average.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Currency Risk:** As the fund invests in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.

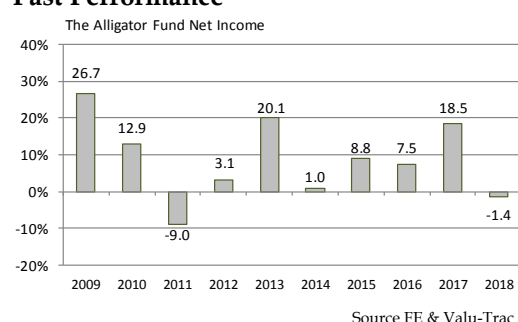
The ongoing charges figure is based on expenses and the net asset value as at 31 December 2018.
