The VT De Lisle America Fund (“the Fund”) a sub-fund of The Mulben Investment Funds (“the Company”) Class B (USD) Net Accumulation (ISIN: GB00B4X7J424)

The Fund is an Open Ended Investment Company. De Lisle Partners LLP is the Investment Manager and Valu-Trac Investment Management Ltd is the Authorised Corporate Director of the fund.

Objectives and investment policy

The Fund will aim to achieve capital and income growth over the long term (5 years).

The Fund will invest primarily (70%) in equities and other investments in America (and may also invest in Canada).

The Fund will invest in, predominantly (80%), listed securities, typically common stock and American Depositary Receipts listed on US exchanges, including exchange traded funds.

The Fund may also invest in collective investment schemes (including those managed and/or operated by the ACD), transferable securities, cash deposits and money market funds as permitted by the FCA Rules.

The Fund has the discretion to invest in a range of investments as described above.

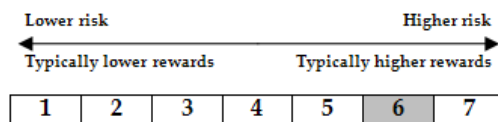
Any income the Fund generates will be reinvested to grow the value of your investment. You can buy and sell shares on any business day in London.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



- The Fund is ranked 6 because funds of this type have experienced significant rises and falls in value in the past. 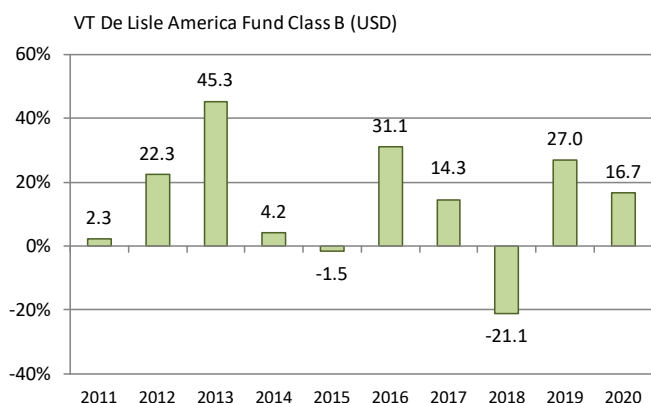
