## Objectives and Investment Policy

The investment objective of the VT Esprit Tactical Balanced Fund is to achieve an investment return (capital growth and reinvestable income) over the longer term (5 years+).

The Fund will be actively managed to achieve its stated investment objective by investing in a globally diversified portfolio. The portfolio will consist primarily (70% or above) of a range of OEICS, Unit Trusts, other collective investment vehicles (providing exposure to asset classes including equities, fixed income, money market instruments, cash, property and commodities (through exchange traded vehicles)) and where appropriate may invest directly in equities, fixed income stocks, money market instruments and cash.

There will be no particular emphasis on any industrial, geographic or economic sector.

Derivatives and forward transactions may be held for efficient portfolio management purposes.

The Fund is suitable for investors seeking long term capital growth through exposure to a diversified range of asset classes. There will be a balance of lower and higher risk assets which may result in periods of volatility and a risk of capital losses.

You can buy and sell shares in the Fund on any business day.

If you hold accumulation shares, income from the Fund will be reinvested to grow the value of your investment.

If you hold income shares, any income from the Fund will be distributed on a semi-annual basis.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically. (For the avoidance of doubt, the risk indicator is calculated on a different basis to the benchmark.)

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.


