VT ESPRIT TACTICAL INCOME





INVESTMENT OBJECTIVE:

VT Esprit Tactical Income targets a yield of 4% to 6% per annum, whilst seeking to protect capital. The fund has the flexibility to invest in a range of asset classes but the income requirement means that equity exposure may be significant at times. We do not follow a traditional asset allocation framework as we want to retain as much flexibility within the fund as possible.

MONTHLY COMMENTARY

Our asset allocation is driven by the requirement to find attractive and sustainable income streams from a diverse range of asset classes. The Tactical Income fund targets a yield of 4% - 6%, rather than making capital gains. Some capital growth would, of course, be desirable over the longer term.


Our current strategies chosen to provide the required income include: UK equity income funds, global equity income funds, high yield bonds, multi-asset funds, investment trusts and UK REITs. Things we are positive about: Economic data since the start of the year points towards a pick up in global activity, whilst business and investor sentiment is improving. The Chinese government will ease fiscal and monetary conditions in response to the coronavirus outbreak.

Things that we are worried about: The coronavirus outbreak is not yet under control, and will likely hurt the Chinese and global economy in the short term. Bond markets and commodity prices appear at odds with the strength of equity markets.


