Objectives and Investment Policy

The investment objective of the Fund is to provide a return of 6.5% (after deduction of fees) over the medium to long term (5-10 years) whilst being managed in accordance with Distribution Technology's 'Risk Level 5' (on a scale of 1 (lower risk) to 10 (very high risk)).

The Fund will seek to achieve its objective by investing at least 80% in active and passive (that is those investments which aim to track the performance of various financial indices) collective investment schemes (including funds managed and/or operated by the ACD) and exchange traded funds through which it will gain exposure to investments including equities, fixed income, alternatives and cash. At least 30% of exposure will be to lower risk assets such as cash, alternatives such as absolute return strategies and fixed income.

The Fund may also invest in equities, fixed income, money market instruments, deposits, cash and near cash.

The Fund's risk profile is managed by restricting the types of assets held and allocations to those assets. The Fund will be managed in accordance with Distribution Technology's 'Risk Level 5' (on a scale of 1 (lower risk) to 10 (very high risk)) and, within Risk Level 5, is expected to be towards the higher end of this risk band.

The Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund will be actively managed.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes.

You can buy and sell shares in the Fund on any business day.

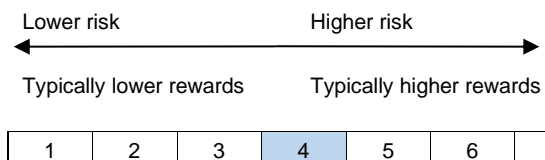
If you hold accumulation shares, income from the Fund will be added to the value of your investment (i.e. dividend income will be included in the value of your shares).

If you hold income shares, any income from the Fund will be distributed four times a year.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.



Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically.

The risk and reward profile above is calculated by the Authorised Corporate Director on a scale of 1-7 using standard calculations based on historic volatility of the Fund. This is calculated differently to the risk scale of 1-10 referred to in the investment objective and policy, which will be calculated by an independent party (currently Distribution Technology although this could change in the future) based on ongoing analysis of the investment process and the portfolio.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.
- Derivatives risk: use of derivatives may result in gains or losses that are greater than the original amount invested

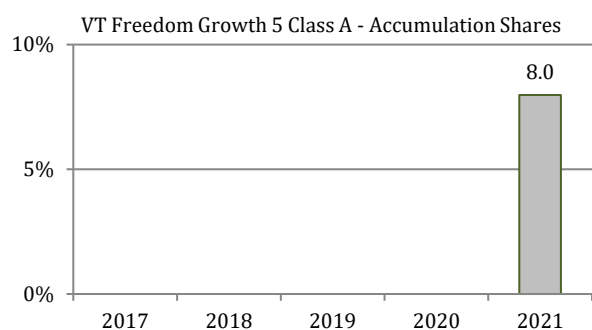
