Objectives and Investment Policy

The investment objective of the Fund is to provide a return of 6.0% (after deduction of fees) over the long term (5 years) whilst being managed with an annualised volatility target of between 6% and 8.5%, over the same period.

The Fund will seek to achieve its objective by investing at least 80% in active and passive (that is those investments which aim to track the performance of various financial indices) collective investment schemes (including funds managed and/or operated by the ACD) and exchange traded funds through which it will have exposure to investments including equities, fixed income, alternatives and cash. There is expected to be a balance between exposure to higher risk assets (such as equities) and lower risk assets such as cash, alternatives such as absolute return strategies and fixed income. At least 40% of the exposure of the Fund is expected to be to such lower risk assets.

The Fund may also invest in equities, fixed income, money market instruments, deposits, cash and near cash.

The Fund may hold derivatives for Efficient Portfolio Management purposes.

As noted in the objective, the portfolio of the Fund will be constructed in such a way that the volatility target for the Fund will be between 6% and 8.5%. For the avoidance of doubt, this does not necessarily mean that actual volatility will be at this level as realised volatility may be different from the assumptions made by the Investment Manager.

The Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund will be actively managed.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes.

You can buy and sell shares in the Fund on any business day.

If you hold accumulation shares, income from the Fund will be added to the value of your investment (i.e. dividend income will be included in the value of your shares).

If you hold income shares, any income from the Fund will be distributed four times a year.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty Risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.
- Derivatives Risk: use of derivatives may result in gains or losses that are greater than the original amount invested

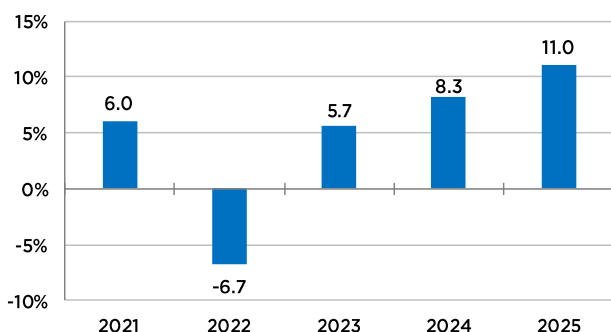
