The Fund is an Open Ended Investment Company. icf management limited is the Investment Manager and Valu-Trac Investment Management Ltd is the Authorised Corporate Director of the fund.

## Objectives and Investment Policy

The objective of the Fund is to achieve capital and income growth over the long term (5 years). Capital is in fact at risk, and there is no guarantee that the investment objective will be achieved over a five year, or any, period.

The Fund will seek to achieve its objective by investing at least 70% in collective investment vehicles (both active and index tracker (including investment trusts and exchange traded funds) and which may include those managed and/or advised by the ACD or Investment Manager) to actively gain exposure (indirectly) to a broad range of asset classes (including equities, bonds (both investment grade and sub-investment grade), commodities, infrastructure and property) on a global basis, including emerging markets (those markets whose economies are in an emerging growth phase and offer higher potential return with higher risks than developed market countries).

The Fund may also invest directly in shares in companies, corporate and government bonds (both investment grade and sub-investment grade), cash, deposits and money market instruments (such as treasury bills).

In managing the Fund, the Investment Manager aims for volatility to be no more than two-thirds of that of the S&P 500. Derivatives may be used by the fund for efficient portfolio management and hedging.

The Fund may also invest directly in shares in companies, corporate and government bonds (both investment grade and sub-investment grade), cash, deposits and money market instruments (such as treasury bills).

The Fund is known as a 'fund of funds' because it invests in a wide range of collective investment schemes that aim to grow your investment. The Fund will also invest in stock exchange listed investment companies and money market funds.

The Fund has the discretion to invest in a range of investments as described above.

Any income the Fund generates will be reinvested to grow the value of your investment.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes.

You can buy and sell shares on any business day in London.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

## Risk and Reward Profile

The Fund is ranked 4 because funds of this type have experienced average rises and falls in value in the past. 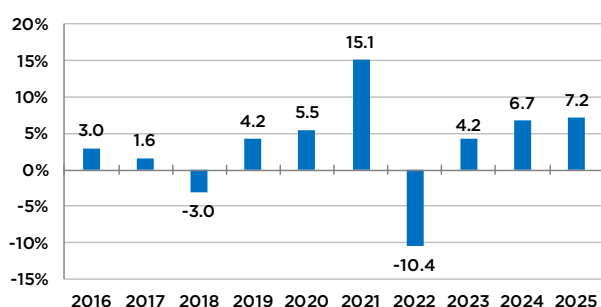
