OBJECTIVES AND INVESTMENT POLICY

The objective of the Fund is to provide capital growth and some income over the medium to long term (7 years).

The Fund aims to achieve its objective by investing in a diversified portfolio of collective investments schemes providing indirect exposure to different asset types (which may include those managed and/or operated by the ACD or Investment Manager) selected from the global marketplace.

The Fund will be managed within the constraints of the IA (Investment Association) Mixed Investment 40% - 85% Shares Sector and as such there is expected to be a balance between exposure to higher risk assets such as equities, defensive assets such as bonds and cash and alternative assets such as absolute return strategies and commodities (using exchange traded commodities).

The Fund may also invest directly in equities, fixed income, money market instruments, deposits, cash and near cash.

The Fund will be actively managed.

Save as noted above the Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund does not intend to have an interest in immovable or tangible movable property.

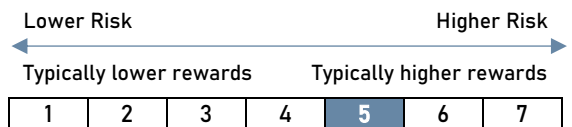
You can buy and sell shares in the Fund on any business day.

RISK AND REWARD PROFILE

The Risk and Reward Indicator table demonstrates where the Company ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.



Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because weekly historical performance data indicates that relatively high rises and falls in market prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.
Derivatives risk: use of derivatives may result in gains or losses that are greater than the original amount invested.

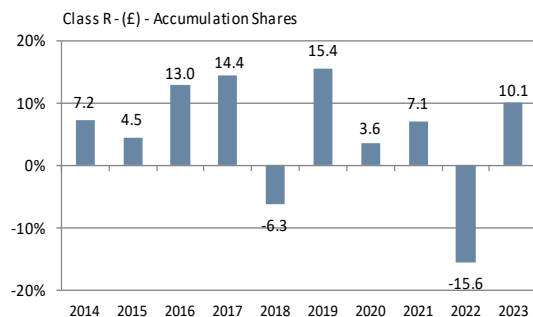
