Objectives and Investment Policy

The investment objective of the Fund is to achieve capital growth over the long term (10 years).

The Fund aims to achieve its objective through exposure of at least 80% to a portfolio of equities throughout the world. This exposure will primarily (at least 70%) be indirect through investment in collective investments schemes (which may include those managed and/or operated by the ACD or Investment Manager), however a limited amount of direct equities may also be used. Exposure to UK equities (that is those companies which are established and/or listed in the UK) is expected to be up to a maximum of 20%.

The Fund may also invest in fixed income, money market instruments, deposits, cash and near cash.

The Fund will be actively managed.

Save as noted above the Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund does not intend to have an interest in immoveable or tangible moveable property.

You can buy and sell shares in the Fund on any business day.

Any income from the Fund will be re-invested to grow the value of your investment.

The Fund is ranked 5 because weekly historical performance data indicates that relatively high rises and falls in prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.


