Objectives and Investment Policy

The investment objective of the VT Halo Asia Growth Fund is to achieve annualised total return of 7 – 11% (after deduction of fees) over 7 years (the length of a typical economic cycle). Capital is in fact at risk and there is no guarantee that a positive return will be achieved over that or any period.

The Fund aims to meet its investment objective by investing primarily (at least 70%) in a portfolio of stocks quoted on Asian markets. The Fund may also invest in other (i.e. non Asian quoted) stocks which have at least 35% of their revenues or profits coming from emerging markets, with at least 70% of the emerging market exposure coming from Asia.

The remainder of the Fund's portfolio may be invested in other collective investment schemes (including those managed and/or advised by the ACD and Investment Manager), shares, bonds, money market instruments, deposits, cash and near cash.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes. It is expected that use of derivatives will be limited.

There will be no particular emphasis on any industry or economic sector.

The Fund is actively managed.

You can buy and sell shares in the fund on any business day.

Any income from the Fund will be re-invested to grow the value of your investment.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because weekly historical performance data indicates that it has experienced relatively high rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Currency Risk:** As the Fund invests in collective investment schemes which have exposure to overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- **Risk from use of derivatives:** Investment in derivatives may result in gains or losses that are greater than the original amount invested.

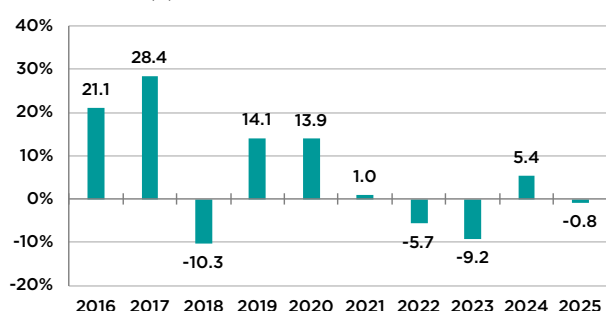
