Objectives and Investment Policy

The investment objective of the Fund is to achieve annualised total return of 7-11% (after deduction of fees) over 7 years (the length of a typical economic cycle). Capital is in fact at risk and there is no guarantee that a positive return will be achieved over that or any period.

The Fund aims to meet its investment objective by investing primarily (at least 70%) in a portfolio of stocks quoted on Asian markets. The Fund may also invest in other (i.e. non Asian quoted) stocks which have at least 35% of their revenues or profits coming from emerging markets, with at least 70% of the emerging market exposure coming from Asia

The remainder of the Fund's portfolio may be invested in other collective investment schemes (including those managed and/or advised by the ACD and Investment Manager), shares, bonds, money market instruments, deposits, cash and near cash.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes. It is expected that use of derivatives will be limited.

There will be no particular emphasis on any industry or economic sector.

The Fund is actively managed.

You can buy and sell shares in the fund on any business day.

Any income from the Fund will be re-invested to grow the value of your investment.


