The Fund is an Open Ended Investment Company. icf management limited is the Investment Manager and Valu-Trac Investment Management Ltd is the Authorised Corporate Director of the fund.

#### **Objectives and investment policy**

The Fund aims to make a positive return for you whether markets fall or rise by growing the amount you invested.

The Fund is known as a ‘fund of funds’ because it invests in a wide range of collective investment schemes that aim to grow your investment. The Fund will also invest in stock exchange listed investment companies and money market funds.

The Fund has the discretion to invest in a range of investments as described above.

Any income the Fund generates will be reinvested to grow the value of your investment.

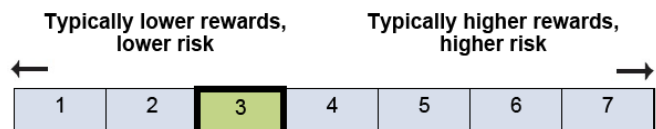
You can buy and sell shares on any business day in London.

#### **Risk and Reward Profile**

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund’s ranking on the Risk and Reward Indicator.



- The Fund is ranked 3 because funds of this type have experienced low to medium rises and falls in value in the past. Please note that even the lowest risk class can lose you money and that extreme market circumstances can mean you suffer severe losses in all cases. The lowest category does not mean “risk free”. The indicator does not take into account the following risks of investing in this Fund:
- The Fund may invest in cash and cash equivalent securities to try to protect its value in times of market uncertainty but this may not always be successful.

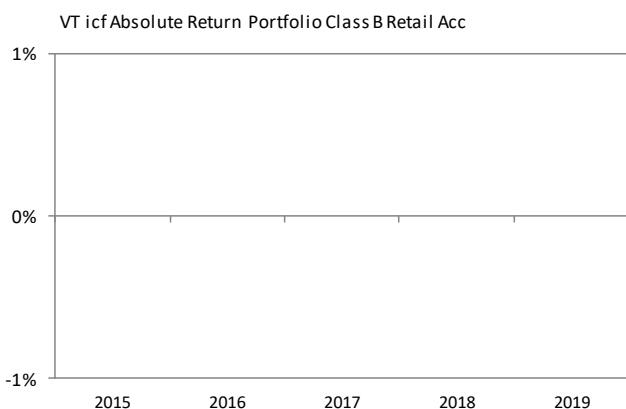
