

**Fund Objective** The Fund seeks to maximize the overall return by seeking to replicate the performance of the Freedom Smart-Beta UK Dividend Index<sup>1</sup>. It is a UCITs fund. The VT Munro Smart-Beta UK Fund will seek to deliver a consistent return over the long term by **Fund Process** holding mainly large and medium sized securities, excluding Investment Trusts, listed on the London Stock Exchange. The Fund will be constructed on the basis of the underlying fundamental financial attributes of the companies listed on the London Stock Exchange rather on their market capitalisation. The weight of each company in the Fund will be determined by the proportion that its forecast total dividend will be expected to make of the total income of all the companies held. The Fund distributes every month and can be considered to be managed with the aim of replicating the performance of the Freedom Smart-Beta UK Dividend Index which is constructed on the same basis. **Market comment** The unification of Unilever into a single UK based company has increased the number of its shares (as at 30th November 2020) listed on the LSE and thus dividend payments due to that class. That has the effect of increasing the total dividend payment for the UK market and was the main reason that the forecast for dividend payments for next year increased by 1.5% to £83.8 billion. This was despite a 3% fall in the value of

<sup>1</sup>The Freedom Smart-Beta UK Dividend index is a Sterling based total return index, comprising approximately 300 of the largest dividend paying stocks (excluding Investment Trusts) that are quoted on the London Stock Exchange. While the full universe is initially determined by market capitalisation, the investible universe is reweighted based on expected dividend payout. The Fund aims to replicate the performance of the Freedom Smart-Beta UK Dividend index but will not necessarily be invested in all the constituents.

the dollar which reduces the sterling value of dividends declared in that currency.

Distribution changed from semi-annual to quarterly in September 2013 and to monthly in October 2015.
