

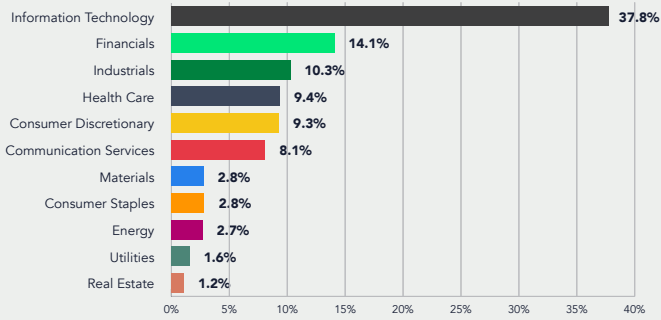
VT North Capital Active Equity Fund

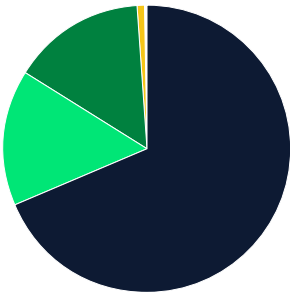
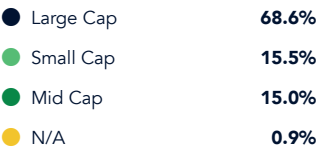
The fund may also invest in equities, fixed income, money market instruments, deposits, cash and near cash.

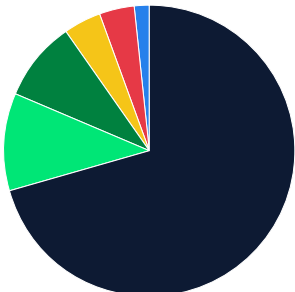
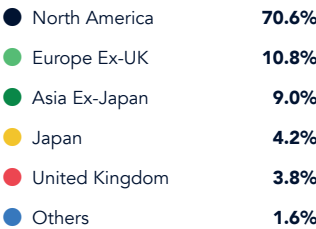
Sector Holdings



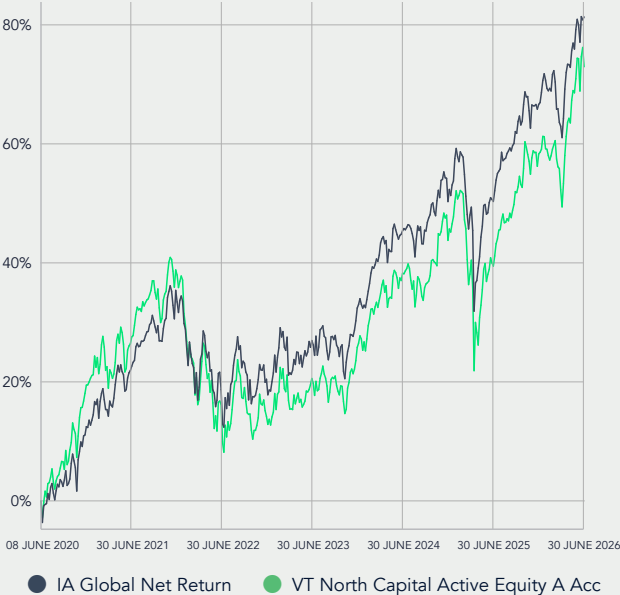
Market Capitalisation
