Objectives and Investment Policy

The investment objective of the Fund is to generate capital growth over the long term (more than 9 years).

The Fund will seek to achieve its objectives by investing at least 80% in collective investment funds (such as OEICS, exchange traded funds and Investment Trusts, and which may include funds managed and/or operated by the ACD or Investment Manager) which will provide exposure to a diversified portfolio but with greater exposure to higher risk assets such as equities and to a limited degree alternatives such as property, infrastructure and commodities, and less emphasis on lower risk assets such as cash and fixed income. Equity exposure will typically be between 80-100%.

The Fund may also invest, directly in equities, bonds (investment grade and sub-investment grade), money market instruments, cash, near cash and deposits. The Fund may use derivatives for the purposes of efficient portfolio management.

Foreign currency exposure through non-UK investments and particularly overseas bonds may be hedged back into £-Sterling.

The Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund is actively managed.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of one or more underlying assets) may be used for efficient portfolio management and hedging purposes.

Save as noted above, the Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

You can buy and sell shares in the Fund on any business day.

Income from the Fund will be added to the value of your investment (i.e. dividend income will be included in the value of your shares).

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Currency Risk:** As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- **Liquidity Risk:** adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.
- **Concentration Risk:** This Fund holds a limited number of investments. If one of these investments falls in value this can have a greater impact on the Fund's value than if it held a larger number of investments.

Charges

You may also be charged a dilution levy on entry to or exit from the fund.

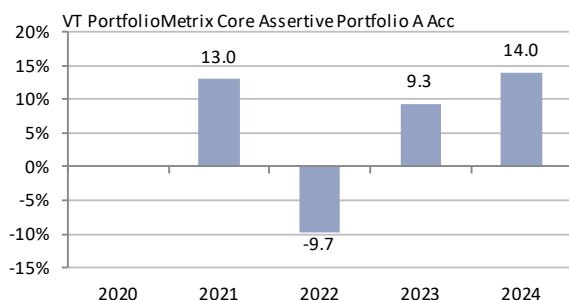

*The ongoing charges figure is made up of:

- (i) the annual management charge payable to the ACD (currently 0.39% per annum)
- (ii) other direct costs to the Fund (currently 0.03% per annum)
- (iii) the costs of the underlying CIS (net of any rebates paid back into the Fund)

The Investment Manager, with agreement from the ACD, has committed to the costs noted in (i) and (ii) being equal to a total of 0.42%.
