Objectives and Investment Policy

The investment objective of the Fund is to generate capital growth and income over the longer term (more than 7 years).

The Fund will seek to achieve its objectives by investing at least 80% in a blend of passive (that is those investments which aim to track the performance of various financial indices) and active collective investment funds (such as OEICS, exchange traded funds and Investment Trusts, and which may include funds managed and/or operated by the ACD or Investment Manager) which will provide exposure to a diversified portfolio but with a balance (around 50%) of exposure (indirectly) to higher risk assets such as equities (and to a limited degree alternatives such as property, infrastructure and commodities) and lower risk assets such as cash and fixed income. It is expected that the exposure to higher risk assets such as equities will typically be between 40-60%.

The Fund may also invest, directly in equities, bonds (investment grade and sub-investment grade), money market instruments, cash, near cash and deposits. The Fund may use derivatives for the purposes of efficient portfolio management.

Foreign currency exposure through non-UK investments and particularly overseas bonds may be hedged back into £-Sterling.

The Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund is actively managed.

You can buy and sell shares in the Fund on any business day.

Income from the Fund will be added to the value of your investment (i.e. dividend income will be included in the value of your shares).

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.

You may also be charged a dilution levy on entry to or exit from the fund.

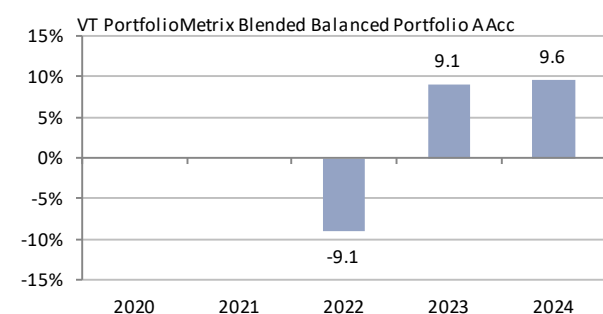

*The ongoing charges figure is made up of:

- (i) The annual management charge payable to the ACD (currently 0.39% per annum)
- (ii) Other direct costs to the Fund (currently 0.03% per annum)
- (iii) The costs of the underlying CIS (net of any rebates paid back into the fund)

The manager, with agreement from the ACD, has committed to the costs noted in (i) and (iii) being equal to a total of 0.42%.
