

## Key Investor Information

### Objectives and Investment Policy

The investment objective of the Fund is to provide a total return through a combination of capital growth and income over the long term (10 years +).

The Fund will seek to achieve its objective by investing in a globally diversified portfolio, primarily (at least 70%) consisting of a range of open-ended funds and other collective investment vehicles such as investment trusts and exchange traded funds (which may include those managed or operated by the ACD and Investment Manager) which will provide exposure to asset classes mainly (at least 50%) equities and to a lesser extent fixed income, money market instruments, cash. There may also be exposure to alternatives such as property and commodities.

The Fund may also invest directly in equities (with such direct equity exposure typically expected to involve between 5 and 15% of the portfolio), fixed income, money market instruments, deposits, cash and near cash.

The Fund will be actively managed.

The Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes.

The Advisor Fund Index (AFI) Balanced Benchmark may be used as a comparator benchmark for this Fund. The performance of the Fund can be compared against that of the benchmark. This benchmark has been selected as it is considered that this index most closely reflects the investments which the Fund will make (and its risk/return objectives) at the current time. For the avoidance of doubt, the Investment Manager is not bound or influenced by the index when making its decisions and can make investments that are not included in the index.

You can buy and sell shares in the Fund on any business day.

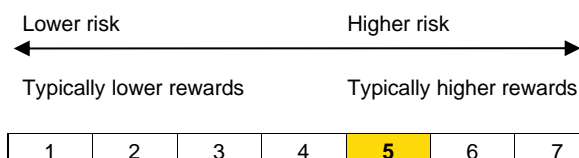
Income from the Fund will be added to the value of your investment.

### Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.



Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because simulated monthly historical performance data indicates that relatively high rises and falls in market prices would have occurred historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of assets.
- Derivatives risk: use of derivatives may result in gains or losses that are greater than the original amount invested
