Objectives and Investment Policy

The objective of the Fund is to provide capital growth.

The Fund seeks to achieve its objective primarily by investing in collective investment vehicles (for example investment companies and exchange traded funds) provide exposure to various different asset classes including equities and fixed income securities. The Fund may also invest in other collective investment schemes, transferable securities, money market instruments, deposits, cash and near cash.

There is no particular emphasis on any geographical area or industry or economic sector.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) are held only for efficient portfolio management purposes.

The Fund has the discretion to invest in a range of investments as described above.

You can buy and sell shares in the Fund on any business day.

Any income from the Fund will be re-invested to grow the value of your investment.

Risk and Reward Profile


