OBJECTIVES AND INVESTMENT POLICY

The investment objective of VT Redlands Property Portfolio is to generate capital growth over the long term (5 years +).

The Fund seeks to achieve its objective by investing at least 70% in collective investment vehicles which have exposure to physical property and property related assets (such as real estate investment trusts and other investments which have a property connection). The Fund may also invest in other collective investment schemes (including those managed and/or advised by the ACD or Investment Manager), transferable securities, money market instruments, deposits, cash and near cash.

There is no particular emphasis on any geographical area or industry or economic sector.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) are held only for efficient portfolio management purposes.

The Fund has the discretion to invest in a range of investments as described above.

You can buy and sell shares in the Fund on each business day.

Any income from the Fund will be re-invested to grow the value of your investment.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

RISK AND REWARD PROFILE

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because monthly historical performance data indicates that it has experienced average rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the fund invests in global securities and collective investment schemes that invest in global securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Risk from use of derivatives: Use of derivatives may result in gains or losses that are greater than the original amount invested.

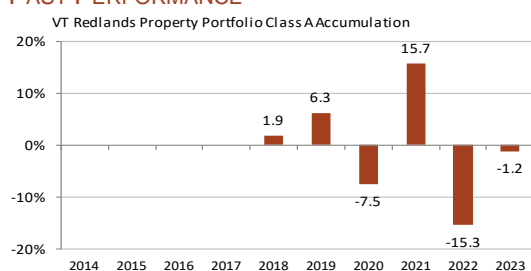
