Objectives and Investment Policy

The objective of the Fund is to achieve long term capital and income growth.

The Fund will aim to meet its objectives by investing primarily in investment trusts and collective investment schemes that invest predominantly in equity securities.

The Fund may also have some direct exposure to bonds and other non-equity investments, including cash, gold and derivatives.

The Fund has no specific limits on exposures to any geographic area or market sectors.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used to achieve the investment objectives or manage the Fund more efficiently.

The Fund allows the ACD to make discretionary choices when deciding which investments should be held in the Fund. These investment decisions will always be made within the constraints of the Fund's objective and investment policy.

If you hold income shares any income from the Fund may be paid out to you.

You can buy and sell shares on any business day.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.

Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because weekly historical performance data indicates that it has experienced average rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Credit Risk:** Bonds and fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up, the value of capital may fall and vice versa. Inflation will also decrease the real value of capital. The value of fixed interest securities is also affected by its credit rating.
- **Market Risk:** External factors can cause an entire asset class to decline in value and given the potential portfolio composition, the net asset value of the Fund is likely to be volatile.
- **Concentration Risk:** the Fund may hold a limited number of investments. If one of these investments falls in value this can have a greater impact on the Fund's value than if it held a larger number of investments.
- **Risk from use of derivatives:** Investments in derivatives may result in gains or losses that are greater than the original amount invested.

Charges

The charges you pay are used to pay the costs of running the Fund, including marketing and distributing costs. These charges reduce the potential growth of your investment.

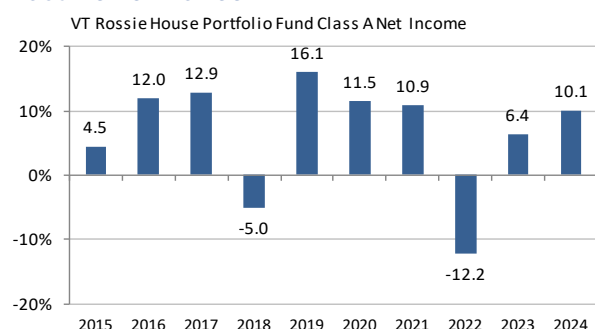
The entry charge shown is a maximum figure. In some cases you might pay less. You can find out the specific charges which apply to your investment by contacting your financial adviser.
