## **Objectives and Investment Policy**

The objective of the Fund is to achieve long term capital and income growth.

The Fund will aim to meet its objectives by investing primarily in investment trusts and collective investment schemes that invest predominantly in equity securities.

The Fund may also have some direct exposure to bonds and other non-equity investments, including cash, gold and derivatives.

The Fund has no specific limits on exposures to any geographic area or market sectors.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used to achieve the investment objectives or manage the Fund more efficiently.

The Fund allows the ACD to make discretionary choices when deciding which investments should be held in the Fund. These investment decisions will always be made within the constraints of the Fund's objective and investment policy.

If you hold income shares any income from the Fund may be paid out to you.

You can buy and sell shares on any business day.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The Fund is ranked 5 because weekly historical performance data indicates that it has experienced relatively high rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- Credit Risk: Bonds and fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up, the value of capital may fall and vice versa. Inflation will also decrease the real value of capital. The value of fixed interest securities is also affected by its credit rating.
- Market Risk: External factors can cause an entire asset class to decline in value and given the potential portfolio composition, the net asset value of the Fund is likely to be volatile.
- Concentration Risk: the Fund may hold a limited number of investments. If one of these investments falls in value this can have a greater impact on the Fund's value than if it held a larger number of investments.
- Risk from use of derivatives: Investments in derivatives may result in gains or losses that are greater than the original amount invested.


The entry charge shown is a maximum figure. In some cases you might pay less. You can find out the specific charges which apply to your investment by contacting your financial adviser.
