

Key Investor Information

VT Shackleton Growth Fund (the "Fund") a sub-fund of VT Shackleton ICVC (the "Company") Accumulation Shares (ISIN: GB00BF0Q2V70)

The authorised corporate director of the Fund is Valu-Trac Investment Management Limited.

Objectives and Investment Policy

The Fund aims to achieve a combination of capital growth and income, net of fees, over an investment horizon of five years.

The Fund is actively managed and obtains exposure (directly and/or indirectly) to a diversified range of asset classes including equities (shares), fixed income securities (corporate and government bonds and other debt securities), money market instruments (debt securities with short-term maturities) and cash.

At least 70% of the portfolio will be invested indirectly through other collective investment schemes (which may include those managed or advised by the ACD or the Investment Manager) and/or exchange-traded products (such as exchange-traded funds).

Under normal market conditions, it is expected that the Fund's exposure to equities will typically be between 60% and 80%; and exposure to fixed income, money market instruments and cash will be between 10% and 40% of the portfolio.

The Fund may invest globally without geographic, sectoral or market capitalisation restrictions.

The Fund may gain exposure to other asset classes (for example, property-related, infrastructure-related and commodity-related exposures) through eligible UCITS-compliant exchange traded products or collective investment schemes, where consistent with the Fund's risk profile.

In exceptional circumstances, including periods of significant market stress, reduced market liquidity, or unusually large redemptions or subscriptions, the Fund may temporarily hold a higher proportion of its assets in cash, cash equivalents, or money market funds than would normally be the case. During such periods, the Fund may also deviate from its typical asset allocation ranges where this is considered by the ACD to be in the best interests of investors and to support the ongoing liquidity and orderly management of the Fund. The Fund will return to its normal investment positioning as soon as reasonably practicable.

Derivatives and forward transactions (financial instruments linked to the rise and fall of the price of other assets) may be used for efficient portfolio management purposes including hedging (although it is expected that use of derivatives will be limited).

You can buy and sell shares in the Fund on any business day.

Any income from the Fund will be re-invested to grow the value of your investment.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area of the table below shows where the Fund ranks in terms of its potential risk and reward based on historical data.

The Fund is ranked 4 because monthly historical performance data indicates that average rises and falls in market prices would have occurred historically. (For the avoidance of doubt, the risk indicator is calculated on a different basis to the benchmark.)

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Liquidity Risk: adverse market conditions may affect the ability to sell certain assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.
- Derivatives risk: use of derivatives may result in gains or losses that are greater than the original amount invested.

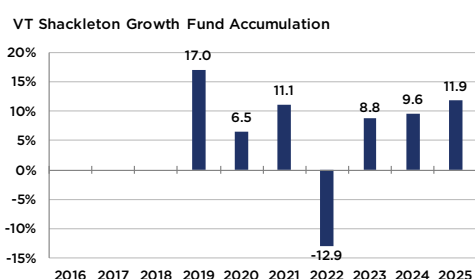
