

VT Smartfund Growth Strategy (the "Fund") a sub-fund of VT Smartfund ICVC (the "Company") F Class Shares (ISIN: GB00BYM31K17)

Objectives and Investment Policy

The fund aims to capital growth over the long term (5 years).

The Fund will seek to achieve its investment objective through investing primarily (70%) in a diversified portfolio of collective investment schemes and other permitted investments that have a similarly diversified character such as investment companies and exchange traded funds (ETFs).

The investments will be selected to achieve a mix of growth and defensive assets. A greater proportion of the portfolio will be allocated to collective investment schemes investing in growth assets (such as shares and infrastructure securities) to provide the potential for capital growth, than to collective investment schemes investing in defensive assets (such as fixed interest and cash).

The fund will apportion its assets between funds that invest in equities, fixed-income, and cash and equivalents to obtain the mix of asset classes most appropriate to achieve its aims and which are consistent with a medium to high risk profile. The fund will allocate more of the portfolio to collective investment schemes investing in growth assets than defensive assets, to provide the potential for capital growth.

The fund may not be fully invested and may hold cash or similarly liquid assets.

The Fund has the discretion to invest in a range of investments as described above.

You can invest in income units which pay the income to the investor on the 15th of each month.

The fund is normally priced every working day and you can take your money out whenever you wish to do so.

Investors should aim to hold investment in this fund for the medium to long term. This fund may not be appropriate for investors who plan to withdraw their money within 5 years.



Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 4 because weekly historical performance data indicates that it has experienced average rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund may invest in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.


