#### Objectives and Investment Policy

The investment objective of the Fund is to generate capital growth over the long term.

The Fund will seek to achieve its objective primarily via exposure (indirectly by way of a total return swap) to a portfolio of defined return investments, namely twelve rolling six year autocalls (each of which will have a potential maturity date on a different calendar month each year) which are designed to provide a defined return if the FTSE 100 is at, or above, a predefined level on a specified date. Capital is at risk and there is no guarantee that a positive return will be achieved over a 12 month, or any, period.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of one or more underlying assets) will be used for purposes of meeting the Fund's investment objectives and may be used for efficient portfolio management purposes.

The Fund may also invest in transferable securities, bonds, money market instruments, deposits, cash and near cash.

Any income from the Fund will be re-invested to grow the value of your investment.

You can buy and sell shares in the Fund on any business day.

#### Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because monthly historical performance data indicates that it has experienced relatively high rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Liquidity Risk:** adverse market conditions may affect the ability to sell certain assets when necessary.
- **Concentration Risk:** The Fund may hold a small number of investments and may therefore be subject to larger than normal movements in its value.
- **Derivatives Risk: use of derivatives may result in gains or losses that are greater than the original amount invested.**

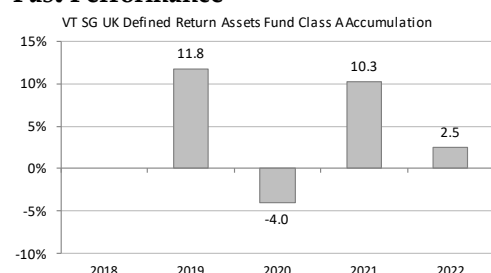
