Objectives and Investment Policy

The objective of the Fund is to generate income whilst also achieving capital growth over the long term (5 years).

The Fund aims to achieve its objective by investing in a concentrated portfolio of equities. At least 50% will be invested in UK equities, with the remainder in global equities. The investment manager will aim to achieve these objectives and spread investment risk through an actively managed and diversified portfolio of equities.

The use of derivatives (financial instruments whose value is linked to the expected future price movements of the underlying assets) and/or hedging transactions are permitted in connection with the Efficient Portfolio Management of the Fund (although derivative use is expected to be limited).

Other than as noted above in respect of a focus on UK equities, the Fund will not have any particular geographic, industry or economic sector focus and as such weightings in these may vary as required.

The Fund is actively managed.

You can buy, sell and switch shares in the Fund on any business day in the UK.

If you hold accumulation shares, income from the Fund will be added to the value of your investment.

If you hold income shares, any income from the Fund will be distributed on a quarterly basis.

The Fund may be suitable for investors who are willing to invest over the long term (5 years).

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because historical performance data indicates that it has experienced relatively high rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- **Counterparty risk:** The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- **Market Risk:** External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- **Liquidity Risk:** adverse market conditions may affect the ability to sell certain assets when necessary.
- **Derivatives Risk:** use of derivatives may result in gains or losses that are greater than the original amount invested. The Fund could take short positions through the use of derivatives which are not backed by physical assets. Short positions reflect an investment view that the price of the underlying asset is expected to fall in value. Accordingly, if this view is incorrect and the asset value rises in value, the short position could involve greater risk due to the theoretical possibility of an unlimited rise in its asset value.

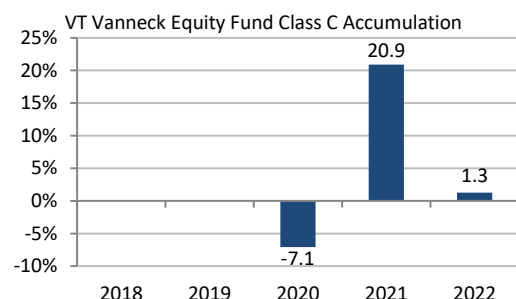
